2.) Graduate profile and learning objectives

a) The institution defines the learning objectives of the study programme such as student's abilities at the time of completion of the programme and the main learning outcomes⁶.

The study program European Studies and Policies aims to provide a comprehensive framework of knowledge, skills and competences in the field of national and European policy to an adequate extent of the III. degree. With its content focus and additional activities (see below), the presented study program responds to the needs of modern practice, which increasingly requires comprehensive training of PhD. graduates in the field of European public policy-making. The study program is therefore developed on the basis of communication with experts from practice as well as employers, and is enriched by activities for the overall development and training of national and European leaders. For this reason, the real results of the educational process focus on the preparation of PhD. graduates with complexity of their skills and competencies with a practical focus, who are ready for independent analytical, academic and research work. A prerequisite for acquiring such transferable competencies is the fact that PhD. students already have a set of knowledge, skills and competences in the field of political science and European studies, i.e. sufficient knowledge needed to analyse the political, social, economic and international aspects of different forms of governance and of individual policies or political actors. PhD students will acquire these skills and competences within the European Studies and Policies study program thanks to its interdisciplinary nature focused on the complex knowledge in the areas of the government and its institutions, the European Union, international relations, gender issues and security, supplemented by knowledge - expertise related to political and social processes at different levels of government.

The graduates of the PhD degree program in European Studies and Policies thus gain an expertise but moreover, practise their wide range of theoretical knowledge in the educational process, which enables them to get expertise in the processes of national and supranational politics, education and training processes and research activities. Within their research activities, they can apply individual international political theories to analyse selected processes taking place within or outside the state. Within their study and expert practise with the Department, they are able to interconnect the acquired knowledge with practice, also thanks to the possibility of gaining practical experience for their future career already during the study. The student can directly apply theoretical knowledge and acquired skills during individual teaching activities (see below), as well as apply to several possibilities of professional practice at home and abroad, thus verifying them and deepening them into a form of practical competencies.

A graduate of the 3rd degree (PhD) of the European Studies and Policies study program deepens his / her knowledge and skills gained from a previous MA study in political science, to an extent and level adequate to the level of study according to the Qualifications Framework in the European Higher Education Area. This scope provides the graduates with extended readiness for analytical tasks in the agenda of national and international organizations. The graduate has an extended and deepened professional and scientific basis necessary for solving individual tasks and, thanks to practically focused teaching and research practise (see below), is able to contribute and participate in the creation of various sectoral policies of a European nature.

As the PhD study program also includes participation in several expert PhD conferences, discussions and workshops, the graduate is able to communicate in domestic and international forums. The graduate deepens the acquired professional and scientific language, skills and competencies necessary for the creation and implementation of European policies, how to use them in creating new policies so as to demonstrate an understanding of the context and consequences of the problem and alternative decisions in designing solutions. Furthermore, the graduate has in-depth knowledge and competencies important for comparing the functioning of policies in an international framework, especially in the European Union, and thus is able to design procedures and tools for solving individual practical problems. The graduate is able to actively characterize the existing socio-political problems based on data and previous research and specify the attributes that are related to them, is able to apply the acquired skills oriented to the decomposition of the phenomenon, as the acquisition of this skill is transferable to any other research. In a research work, the graduate of this study program is, thanks to the acquired experience within the research and publishing activities, able to obtain relevant and correct data with regard to own previous operationalization of constructs. From the overall point of view, the doctoral graduate is able to act in practical professional life as an expert who approaches current socio-political phenomena and challenges with critical thinking, with the ability to identify, name, analyse a scientific problem, then on the basis of relevant data and with regard to current knowledge to carry out research of a specified phenomenon.

Due to the setting of the PhD study and related research/teaching activities taken within it, the graduate is able to organize work in working teams, cooperate in the preparation of public policy at European, national and local levels, analyse needs, identify and name problems, design, create, implement, monitor and evaluate policies, conduct empirical research and interpret its results and apply research recommendations in practice.

The graduate is prepared to understand the interdisciplinary context of the functioning of modern political systems and regimes. And, as the European dimension of policy-making is based on synergy and convergence, graduates are prepared to look for solutions for modern Europe, which is served by a number of practical activities carried out directly in the teaching process.

The doctoral study prepares graduates for a wide range of jobs not only in the academic, but also outside the academic, i.e. in political, research, non-governmental and other professional spheres. The graduate acquires an extensive set of skills that can be applied in different situations and occupations (see below). Although doctoral graduates are generally expected to pursue academic / research careers, the skills acquired by doctoral students are not presented exclusively in an academic context. However, they are still applicable to a wide range of positions and tasks in the national politics, European institutions, local government or non-governmental sector.

The range of knowledge enables the graduate to enter practical life or pursue an academic or research career. Graduates of the study program European Studies and Policies are successful in finding their employment in state administration bodies, self-government bodies, public bodies, scientific research and pedagogical institutions, supranational institutions, analytical organizations, but also in the private sector, and/or in the field of volunteering, in various positions (see below).

The package of knowledge, skills and competences (see attachments) covers several areas, such as teamwork, time management, research skills within the given study program, work with professional resources and relevant information, skills in the field of professional text preparation, academic writing and related presentation skills. As part of presenting the results of their research at various domestic and foreign events, they acquire a high level of communication skills and the ability to lead a quality professional discussion.

Time management is developed during the study, as the study itself is divided between several time limits (for example to complete a research or dissertation project) with different deadlines, so time management is an important skill for future PhD-graduate practice. During their studies, students develop their skills in writing expert texts as well as grants, thus acquiring the necessary skills for future. As doctoral students work independently (under the supervision of their supervisors and senior colleagues) on independent scientific and grant assignments, the study also brings development of skills and competencies in the field of data analysis, independent decision-making and, problem solving. Senior students of doctoral studies are involved in the mentoring program for BA / MA students, thanks to which their leadership skills are developed.

This program joins efforts to prepare European policy experts who will focus on achieving qualitative results based on deeper quantitative studies. As the presented study program deals with the solution of the problems of human society at present, the content of individual subjects therefore reflects the current events. For this reason, through several activities PhD students are motivated and challenged during their PhD studies to address issues in crisis situations in society, such as the current COVID-19 pandemic, i.e. such as public policies aimed at achieving economic stability and growth, environmental quality management or ongoing social and political changes. In general, the aim of the doctoral degree is to prepare the graduate to solve these problems systematically and at the same time to establish a broader theoretical context. Graduates and their ability to compare and work with individual European policies and political discourses are in-depth and have the competence to collaborate on background and database studies that will determine societal priorities. Graduates thus have the potential to become impartial professionals in the field of policy analysis, European studies and processes, who could find employment in analytical units or similar government departments or European institutions.

The student qualifications achieved after completing the third cycle of the European Higher Education Area (level 8) are as follows:

3.) Employability

a) Evaluation of the study programme graduates employability.

The implementation of the study program so far proves that a substantial part of the graduates of doctoral studies have been actively involved in the work cycle, i.e. within the achieved qualification and expertise of the graduate, as the graduates still successfully perform internships during their studies, especially in state institutions such as the National Council of the Slovak Republic, the Office of the Government, the Representation of the EP in Slovakia, resp. in foreign institutions, i.e. in connection with the acquired education, the employment of doctoral graduates is relatively extensive (see above). This proves that the doctoral study of the European Studies and Policies program is designed so that its graduate is professionally prepared to perform the tasks of theory and practice in accordance with current needs of social development not only in Slovakia but within the European Union and its institutions and therefore the graduate doctoral study has the prerequisites to perform methodological and analytical work and the ability of active, conceptual, creative activity, e.g. analysis of methods, design and organization of research, management work in state administration and self-government.

Within its core, the study program educates experts ready to participate in the creation of policies and processes at the level of state administration, international organizations, and/or in the private sector and prepares them for the positions of modern leaders. The graduate acquires a sufficient basis of theoretical knowledge in political science, especially European policies and theories of Europeanization and the history of integration trends of the European Union and language skills to be able to enter and apply in several areas of society (pedagogical activity, public administration, civic associations, mass media, international organizations, etc.). The graduate is prepared to be able to independently, creatively and effectively solve problems, present alternatives and communicate effectively with partners at home and abroad. Another possibility is a professional work in the field of political counselling, scientific research, political life, pedagogical and journalistic work. State and public administration structures (state and self-governing institutions of the national, regional and local level), as well as third sector entities, civic associations and foundations, are important areas of employment for European Studies and Policies graduates.

Doctoral graduates in European Studies and Policies are also prepared for a professional career as a university teacher and academic and research carriers. Graduates of the master's degree are ready to enter the internship and at the same time have all the prerequisites to continue their post-doctoral studies at the universities in Europe and around the world.

The above profile of the PhD graduate also defines the most important knowledge, abilities and skills that the graduate of the study program acquires in the third stage of university education. In addition to the basic knowledge that students acquire by completing the core subjects of the study program, they have the opportunity to complete their profile by studying compulsory elective subjects, special trainings and learning modules, study and teaching mobilities. In this way, they expand the range of their knowledge in accordance with individual interests, and/or by its professional expertise. PhD students also complete the necessary language training, which is inevitable for making internationally valued research. Students also deepen their language knowledge and skills by completing professional internships at foreign institutions and by completing Erasmus + study stays at European universities.

Graduates of the PhD degree gain extensive knowledge not only in the field of European Studies and Politics, but also in the basics in some related scientific disciplines, which will be able to use in professional practice, if necessary to further deepen them. As a result, they are optimally prepared to work in the institutions of the European Union, respectively for other international organizations, state bodies, public administration, political parties, civic associations as well as the mass media.

As the content of education follows the industry-specific expectations in terms of knowledge, skills and competencies from the perspective of the labour market, the Department sets goals and outcomes based on information about the employment of its graduates in the labour market, especially in terms of their position in connection with the study. The processes set up in this way enable the Department to obtain information on the needs of the labour market in the area in which it prepares professionals, and thus to update and innovate the set of graduates' competencies. This contributes to the flexibility of the content of teaching and thus to the modulation of the teaching program, to the inseparability of the results of non-formal learning achieved from theoretical training and thus contributes to the segmentation of qualifications and recognition within the European framework. In the sense of the above, in the implementation of individual levels of education, it is necessary to reflect and adapt the desired qualification requirements to the individual levels of education provided. For this reason, the Department implementing this study program ensures

In accordance with the wording of the European Qualifications Framework and the National Qualifications Framework of the Slovak Republic, the core competencies set by the graduate after completing this study program ensure that they can solve problems, coordinate procedures in teams and independently and responsibly make decisions in a changing environment, be responsible for their actions and decisions, taking into account the wider social consequences, able formulate information on the progress and results of solving tasks, as well as communicate their expert opinions with other experts.

Thanks to the acquired experience, students are aware of their social responsibility in the process of applying their knowledge and decisions in practical work and social life;
- Following the above, graduates become students who can communicate clearly and unambiguously the conclusions and reasons for their taking;
- In connection with the experience gained with various forms and methods of education, graduates thus become students who have developed educational skills that allow them to continue their studies with a high degree of independence and autonomy, recognizing the importance of lifelong learning.

The graduate also acquired these competencies due to the consistent implementation of innovative and creative methods in both formal and non-formal education (see Attachment 16a for more details).

- FSV switched to full distance education during the first wave of the pandemic. It must be stated that the transition to distance learning was smooth and, despite the unpreparedness for such a situation, also relatively fast:

- All teaching was transferred to the online system in the first weeks of March 2020.
- In the first weeks, it was possible to use more platforms for teaching. The platform ZOOM, Google Meet, Moodle was used.

- Shortly before the transition to online teaching, instructional trainings focused on teaching in the online space were carried out at the level of individual FSS departments.

d) Institution partners in providing educational activities for the study programme and the characteristics of their participation.

As above, the partners are involved in the provision of educational activities of the study program in several ways, namely:

- by providing short-term internships for PhD students with an emphasis on the application of acquired theoretical knowledge and skills in practice;
- they are further involved in the preparation and organization of professional discussions, workshops and trainings specialized in the development of acquired knowledge and skills within the assigned topic related to the content of education;
- the involvement of students in project and educational activities carried out by the partners, which includes the possibility of students participating in the implementation of their activities at home and abroad, thus enabling PhD students to verify their acquired knowledge and skills and acquire transferable competencies in the field;
- providing counselling and assistance in workplace activities focused on personal development of students in their preparation for future careers.

e) Characteristics of the possibilities for social, sports, cultural, spiritual and social activities.

The Faculty organizes a number of events in three main forms:

- Events indirectly linked to the content of the study, namely social, sports, cultural, spiritual and social activities, the main task of which is to strengthen the educational institution's relationship with students, develop their soft skills and support teamwork (e.g. Dean's Cup Football Tournament, Sports FSS UCM day, Valentine's volleyball tournament, Barbecue and other activities such as the 2019 EU Olympics for high school students - in case of interest, the students of the study program also have the opportunity to participate in its course)
- Events directly linked to the content of the study but in the form of an informal part of the educational process (e.g. various discussions with experts, film club, trainings focused on public speaking as a personal brand, public speaking culture, rules of good presentation such as assertiveness in terms of communication skills, and others).
- Events as a real and direct part of teaching (as trainings and workshops directly linked to the thematic focus of the subject and directly linking the acquired knowledge with their practical application, such as creative workshops in creating branding in Slovakia, determining national identity, workshops on the role of Slovakia in the so-called green deal, trainings and workshops focused on civic participation in the EU environment, etc. focused on discussion, reflection and design of concrete solutions for the future of Europe)

Doctoral students actively and regularly participate in a number of educational, training and other activities that increase their skills and competencies in the field of their profiling, such as:

- Training for youth workers in inclusive projects;
- Youth exchange - preventing radicalization and combating extremism ("Say No to Extremism");
- Strategic Partnership on Gamification and Youth Work in the Field of Media Literacy (GaMEfy project);
- Strategic partnership - Youth Inspires Politics project - awareness of the possibilities of youth participation at the level of public life;
- Strategic partnership project DIGI YOUTH - digitization and youth work;
- Strategic partnership EUR VOICE project - active citizenship and youth participation;
- Peer2Peer media literacy training for youth workers;
- Faces of Diversity media literacy training for youth workers;
- Learning Trnava project - part of a strategic, networking, PR & Event team (project within the UNESCO platform - Learning cities);
- Cooperation with OZ Nenápadní hrdinovia (Inconspicuous Heroes NGO) - bringing the stories of victims of communism and heroes of the previous regime, and others, i.e. trainings and activities carried out by doctoral students of the Department in the position of experts and trainers in cooperation with partner organizations at home and abroad.

The activities are prepared by the department independently or in cooperation with its partners, which include e.g. SAIA, ERASMUS +, OZ European Dialogue, Learning Trnava, Representation of the Slovak Republic to the EC, Ministry of the Interior, Ministry of Culture, Ministry of Foreign and European Affairs, National Council SR, Ministry of Labor, Social Affairs and Family of the Slovak Republic, Organization for Security and Cooperation in Europe, Agricultural Paying Agency, Slovak Institute for Security Policy.

The Department of Political Science creates active environment for its students, so that during their studies they can acquire several practical skills in various institutions and organizations and thus combine the acquired theoretical knowledge with practice. The Department of Political Science continues its active cooperation in direct teaching and research / project activities with the following institutions: National Council of the Slovak Republic, Ministries (Foreign Affairs and European Affairs; Labour, Social Affairs and Family, Ministry of Economy), EP Office in Slovakia, EC Representation in Slovakia, the Fire and Rescue Corps in Žilina, Self-governing Region (Trnava), Municipal Offices (Unín, Kátlovce), Political Party (Progresívne Slovensko), Iuventa, Youth Council of Slovakia, Európsky Dialóg NGO, and SAIA.

The outline description of the study programme is used to process Annex 2 of the application for granting the accreditation of the study programme.

The Department followed the cooperation with the Ministry of Foreign Affairs of the Slovak Republic and expanded its cooperation with several Slovak embassies, especially with the Slovak Embassy in Ukraine, with several non-governmental organizations such as the Media Initiative for Human Rights, Crimea SOS and the Slovak non-governmental organization „Sme Spolu“. The Department also continued in cooperation with the Faculty of Arts, Comenius University in Bratislava and the Slovak Society for Foreign Policy (SFPA). The Department has started cooperation with Television TA3 on the preparation and implementation of the discussion program "Ako ďalej Európa" ("What's next, Europe?"), which is focused on the discussion of MEPs for the Slovak Republic and representatives of citizens and students about the future of the EU. The discussion is part of a wider project in the context of the ongoing Conference on the Future of the EU. It is a presentation of the views of citizens, students and MEPs on the topics that resonate in the CoFoE citizens' panels and a discussion of the current state of the area in EU legislation, as well as possible changes or adjustments to future contracts based on citizens' suggestion.

The Department has started a new cooperation in the field of providing training for PhD students - the future leaders, and developing soft skills of students with the Slovak Coaches Association, GrowWithGoogle within the New Generation of Founders program, with experts from practice in building personal brand within the project "With Tina" (Tina Nekudová). In order to deepen students' knowledge and skills in the field of research and work with data, the Department has launched cooperation with the authors and implementers of the Open Data Lab project focused on working with open data.

On February 25, 2019, the Framework Agreement on Cooperation between FSS UCM in Trnava and the Institute of Political Sciences of the Slovak Academy of Sciences in Bratislava was renewed with the aim of expanding and deepening the scientific foundations of political phenomena and European unification processes and the need to disseminate political science in the pedagogical process.

The Department of Political Science FSS UCM in Trnava actively cooperates in expanding scientific research cooperation, namely with the Institute of Sociology SAS, Faculty of Political Science and International Relations UMB, Faculty of Education UMB, Department of Political Science FF UPJŠ, Department of Political Science TNUNI, Institute of Psychology FF UNIP, Department of ethic and civic education of the Faculty of Education (Comenius University in Bratislava), as well as foreign universities (Czech Republic, Poland, Greece, Slovenia, Canada, Bulgaria), and others.

Conditions for the participation of doctoral students in mobility and internships:

- all full-time students can apply after completing at least the first year. The selection procedure takes into account not only the study results of the candidate for the internship, but also his participation in activities carried out within and outside the teaching process, his language and communication skills. The interest of the given student in the field in which he / she would perform the internship / mobility is taken into account.

Rules for recognition of this education:

- During the internship/mobility, the PhD student works in accordance with a previous agreement with teachers in the so-called mode of Individual study plan. In the case of international mobility through SAIA or ERASMUS + programs, the university follows the generally applicable rules for applying for and recognizing credits.

10.) Feedback on the quality of provided education

a) Procedures for monitoring and evaluating students' opinions on the study programme quality.

The collection of information for monitoring and evaluating students' opinions on the quality of the study program is carried out in periodic cycles. FSV regularly collects, processes, analyses and evaluates information on: study, students, study programs, study results, changes in study programs, subjects, evaluation of education and teachers by students, etc., but also about teachers, working and at least once a year. burden, qualification growth, creative activity, evaluation of education by teachers, etc. It includes monitoring, evaluation and improving the quality of teachers' work and scientific activities.

FSV UCM also uses informal tools to gather information on the quality of study programs and teachers (e.g. regular informal meetings "Spend a word with the Dean", as well as personal interviews with students, or e-mail communication, through workshops, academic meetings, commission meetings, hospitalization as well as online chat on social networks, etc.)

b) Results of student feedback and related measures to improve the study programme quality.

The results of student feedback are processed by the Study Program Board (RŠP), which ensures at least once a year that feedback is obtained from an internal stakeholder, in this case students. RŠP, after obtaining relevant feedback and its subsequent analysis, at least once a year, will ensure that the internal stakeholder (students, employees) is informed about the results of inquiries, but especially about acceptance or non-acceptance of suggestions to improve the quality of the study program in indirect written form (written report published), or in direct form group interviews (published date and time of the event). At the same time, it will propose measures to increase the quality of the study program.

The final report on the measures taken will be part of the final report of the Faculty Quality Board. The quality council of the faculty prepares documents and analyses for current information of the university management, prepares documents for the meetings of the Scientific Board of the Faculty of Social Sciences UCM, prepares documents for periodic quality assessment by the Council for Internal Quality Assessment

In addition, FSV UCM provides and creates active conditions for its students so that during their studies they can acquire specific knowledge necessary for practice and at the same time transform them into practical skills through internships in various institutions and organizations and thus link theoretical knowledge with practice. Subsequently, the Faculty receives feedback from the internship providers in the form of proposals to supplement or expand the content of the study program. The heads of departments also hold meetings with internship representatives on a regular basis (at least once a year) in order to find out the feedback to the level of students and to implement the necessary innovations in the information sheets of the courses.

c) Results of graduate feedback and related measures to improve the study programme quality.

In addition, the Department providing the study program / RŠP periodically (1x / year graduates, 1x / 3 years employers) will ensure obtaining feedback on the quality of the study program.
